

- Promote awareness of this policy among our employees, enabling them to integrate sustainability principles into procurement and purchasing decisions on behalf of our company.
- Communicating Telko sustainability expectations and requirements towards value chain via Telko supplier code of conduct.
- Developing the supply chain management, including responsible sourcing, monitoring supplier performance and development.
- Reduce value chain emissions by engaging our suppliers to SBTI.
- Purchasing all palm oil and palm oil-derived products from independently verifiable, legal, and responsibly managed sources.
- We are committed to conducting business in a legal, ethical, and responsible manner, and we do not knowingly support, contribute to, or benefit from any activities that violate human rights.

This policy will be communicated through our intranet and external web pages. It will also be disseminated in relevant training sessions and meetings to all employees, customers, suppliers, and the public. All employees are expected to cooperate and assist in implementing this policy while ensuring their work is carried out without risk to themselves, others, or the environment. The Head of HSEQ is responsible for the evaluation of this Policy on an annual basis.
